GENERAL INFORMATION

- 1. Students who wish to benefit from the learning mobility must be enrolled in an undergraduate or graduate program at OSTİM Technical University and must be registered as full-time students during at least one semester of the 2025-2026 academic year in which the mobility will take place (a full academic year requires 60 ECTS, and one semester requires 30 ECTS, which may consist of courses or non-course requirements). Exceptions are considered separately
- 2. Students may apply for Learning Mobility except for those enrolled in the preparatory class, those in the first semester of the first year, and those in the final year of undergraduate programs. All other undergraduate students, as well as graduate students who have progressed to the thesis stage of their programs, are eligible to apply
- 3. Minimum GPA requirements: Associate / Undergraduate level: 2.20, Graduate level (Master's): 2.50
- 4. Applications will be submitted via the Turkish National Agency Erasmus Application Portal using e-government credentials.
- 5. Within the budget allocated to our institution, grant support will be provided to a total of 17 **students**. If additional budget is allocated, this number may increase.







6. Quotas: One quota per department within faculties:

Faculty of Engineering: 8 quotas Faculty of Architecture: 2 quotas

Faculty of Economics and Administrative Sciences: 5 quotas

Graduate School of Social Sciences: 1 quota Graduate School of Natural Sciences: 1 quota

- 7. Quota Transfer Rule: If the allocated quotas in units cannot be filled, quota transfer will be carried out among units, starting from the departments with the highest student density.
- 8. Mobility can only be realized with the universities and departments with which our university has bilateral agreements. If your department does not have an agreement, your application will not be evaluated. Click here to see our agreements.
- 9. Being selected does not guarantee mobility. The host institution has the right not to accept you.
- 10. Students who were selected in the previous term but did not realize their mobility cannot be transferred directly to the following year. A new application is required.
- 11. All students who meet the eligibility requirements may apply, regardless of nationality. There is no restriction for foreign students.
- 12. The possible period for Erasmus+ Student Learning Mobility activities for the Spring Semester of the 2025-2026 Academic Year covers 01 February 2026 – 31 July 2026. Activities must start no later than 15 February 2026 and must be completed no later than 31 July 2026.
- 13. International Students: Applicants are required to upload both their 'Residence Permit of the Republic of Türkiye' and the personal information page of their passport to the application system. Only documents valid between 01.02.2026 and 01.08.2026 will be accepted. The Residence Permit must be uploaded as a single PDF file including both front and back sides, while the relevant page of the passport must be uploaded as a separate PDF file.
- 14. If the minimum duration (2 months) is not completed, the activity will be deemed invalid and any grant advance will be refunded.
- 15. Students who are selected for Learning Mobility but fail to participate without submitting a withdrawal notification within the specified period shall be subject to a penalty of negative points in their subsequent Erasmus+ mobility applications, except in cases of force majeure (e.g., failure to obtain a visa).







APPLICATION EVALUATION CRITERIA

The evaluation will be based on a scoring system. The scoring will be carried out over a total of 100 (one hundred) points, taking into account the evaluation criteria specified below and their corresponding weighted scores:

Academic achievement level (according to 100 point system)	%50
Language level	%50
For children of martyrs and veterans	+15 points
Disabled students (provided that the disability is documented)	+10 points
Previous utilization (with or without grant)	-10 points
Participation in mobility in the country of citizenship	-10 points
For students who have been granted protection, care or shelter under the Social Services Law No. 2828	+10 points
Applying for both study and internship at the same time (for the mobility of the student's choice)	-10 points
Failure to participate in the mobility without submitting a waiver notification in due time (applied if the student reapplies to Erasmus)	-10 points
Those who themselves or their 1st degree relatives receive disaster victim assistance from AFAD	+10 points
For students selected for mobility: Failure to attend meetings/trainings organized by the higher education institution regarding mobility without an excuse (applicable if the student re-applies to Erasmus).	-5 points
Failure to take the language exam without an excuse (applied if the student reapplies to Erasmus)	-5 points

- In the final evaluation list, each student is ranked according to their score in comparison with other applicants from the same department. In cases where candidates from the same department have equal scores, priority is given to the student with the higher academic achievement grade. If the academic achievement grades are also equal, priority is given to the younger student
- Evaluation criteria are determined according to the <u>2024 and 2025 Handbook on the Implementation</u> of Student and Staff Mobility between Programme and Partner Countries.







FOREIGN LANGUAGE

- 1. Students must apply with the results of the Proficiency Exam, TOEFL, or Foreign Language Exam organized by our university.
- 2. A minimum foreign language score of 60 (sixty) points shall be required for all students participating in the mobility
- Minimum foreign language score: 60 points (undergraduate level). 3.
- 4. Students who fail to achieve the minimum score will not be evaluated.
- 5. Written exam counts for **75%** and oral exam for **25%** of the foreign language score.
- 6. The results of the exams held on 04 April 2023, 20-27 September 2023, 18-20 September 2024, and 19-26 March 2026 will be accepted for this application period.

GRANT

- 1. Erasmus+ study mobility students will receive monthly financial support.
- 2. The grant payment shall be made in two installments. The first installment, amounting to 80% of the total grant, shall be transferred to the student before the start of the mobility, while the remaining 20% shall be transferred to the student's account following their return. Students who cannot be allocated a grant may withdraw or participate as "zero-grant" students.
- 3. Individual Support Grant Amounts: Group 1 & 2 Countries: €600/month, Group 3 Countries: €450/month
- 4. The table of individual support grant amounts to be applied to students in the program countries is given below:

- 5. Students who are entitled to participate in learning mobility with a grant will receive funding for a maximum of 180 days in the case of a one-semester mobility. For students whose mobility ends earlier than this duration, the grant will be provided proportionally to the actual period of mobility. The mobility period starts with the beginning date of the academic calendar and ends with the date of the last final exam.
- 6. Except for technical reasons, students who fail to complete the participant survey shall face a deduction of 20% from their total final grant.
- 7. For students who are unsuccessful during the mobility, a deduction of not less than 5%, and between 5% and 20% of the total grant, will be applied depending on the course load undertaken.
- 8. If the documents proving the completion of the mobility are not submitted, the mobility shall be deemed invalid and no grant will be paid to the student; any amount of the grant already paid in advance shall be recovered.
- 9. Additional Grant Support Criteria Document: Students requesting additional grant support must submit official documentation proving their status through the application system at the time of application. Otherwise, the request cannot be considered.
- 10. Participants with special needs and disadvantaged backgrounds may be provided with Additional Grant Support in addition to the regular grant. For student mobilities lasting between 2 and 12 months, an additional monthly grant of €250 shall be provided. A disadvantaged participant is defined as an individual with limited economic and social opportunities, falling under one of the following categories:
 - Students subject to Law No. 2828 (those under protection, care, or shelter orders issued by the Ministry of Family and Social Services),
 - Students under protection, care, or shelter orders within the scope of the Child Protection Law No. 5395,
 - Students receiving an orphan's pension,
 - Children of martyrs or veterans,
 - Students who themselves or whose families receive a subsistence allowance (it shall be sufficient to provide documentation proving that the student, their parents, or legal guardian received financial support during the Erasmus application period from municipalities or public institutions such as Ministries, Social Assistance and Solidarity Foundations, the General Directorate of Foundations, the Turkish Red Crescent, AFAD, etc.),
 - Students with disabilities (those certified by a medical board report with a minimum of 70% disability rate, in accordance with the Regulation on Disability Assessment for Adults published in the Official Gazette No. 30692 dated 20 February 2019 – see Regulation Link),
 - Students whose parent or legal guardian receives a disability or subsistence allowance under Law No. 2022 of 01.07.1976 on "Pensions for Destitute, Helpless and Homeless Turkish Citizens over the age of 65 and for Disabled and Destitute Turkish Citizens."
- 11. Types of mobility and the corresponding amounts of additional grant support shall be specified in a separate table.
